Descriptive Biography

Henry Farrell is SNF Agora Professor at Johns Hopkins School of Advanced International Studies. Previously, he was professor at George Washington University's Department of Political Science and Elliott School of International Affairs. He has also been a fellow at the Woodrow Wilson Center for International Scholars, Assistant and Associate Professor at George Washington University, Assistant Professor at the University of Toronto, and a senior research fellow at the Max-Planck Project Group in Bonn, Germany. He works on a variety of topics, including the relationship between democracy and information technology (currently, Large Models), the security consequences of international economic networks, and international political economy. He is the 2019 recipient of the Friedrich Schiedel Prize for Politics & Technology, a prize for "outstanding individuals who contribute to inter- and transdisciplinary projects linking politics and technology," awarded jointly by the Friedrich Schiedel Foundation and the Technical University of Munich.

His first book, *The Political Economy of Trust: Interests, Institutions and Inter-Firm Cooperation*, was published in 2008 by Cambridge University Press, and his second (with Abraham Newman), *Of Privacy and Power: The Transatlantic Fight over Freedom and Security*, was published in 2019 by Princeton University Press. It is the 2019 recipient of the Palmer Civil Liberties Prize, awarded by Chicago-Kent College of Law and the 2020 ISA-ICOMM Award. Most recently, he and Abraham Newman are the authors of *Underground Empire: How America Weaponized the World Economy*, which won the Council of Foreign Relations 2024 Arthur Ross Bronze Medal for Best Book on Foreign Affairs, was described by Paul Krugman in the *New York Times* as 'revelatory,' and by Dani Rodrik as the book you 'need to read' if 'you want to understand where the world economy has been and where it may be headed.' In addition he has authored or co-authored over 40 academic articles for journals including *Nature*, *Science*, the *American Political Science Review*, *International Organization*, *World Politics*, *Comparative Political Studies* and *International Security*, as well as numerous book chapters for edited volumes.

Professor Farrell is a member of the Council on Foreign Relations, a council member of the European Council of Foreign Relations, former co-leader of the Moral Economy of Technology initiative at Stanford University's Center for Advanced Studies in the Behavioral Sciences, and a Foreign Correspondent for *Stato e Mercato*. He is a co-founder of the popular academic blog Crooked Timber, and was Editor in Chief of *The Monkey Cage*, at the Washington Post and which won the 2010 The Week award for Best Blog. He has written articles for general publications including *Foreign Affairs*, *The New York Times*, *The Financial Times*, *The Wall Street Journal*, *Foreign Policy*, *Harvard Business Review*, *The National Interest*, *The American Prospect*, *The Washington Monthly*, *The Boston Review*, *The American Interest*, *Democracy*, *New Scientist*, *The Nation*, *Aeon*, *The Chronicle of Higher Education*, *Times Higher Education*, and the *Australian Academic Supplement* among others.
